**Proposal:** Conversion of approximately 1,888 sf of a type-F stream buffer for a driveway.

Island County has reviewed the proposed project for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS). The optional DNS process established by WAC 197-11-355 is being used. The determination is based on the following findings and conclusions:

Applicants submitted a Biological Site Assessment prepared by Polymer Land Consultants, LLC on September 7, 2025. The report determined that the proposal is unlikely to adversely affect listed species and their habitat due to the mitigation planting plan that was submitted addressing avoidance, minimization, rectification, & compensation. BMPs will be implemented throughout the duration of the proposed development.

Island County regulations under ICC 17.02B (Critical Areas), Title XI (Land Development Standards) & other applicable regulations are used to review and condition development to protect critical areas affected by this proposal. The proposal may include mitigation & the project review process may incorporate or require mitigation measures regardless of whether an EIS is required.

**Public, Agency, and Tribal Comments:** Agencies, tribes, and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. The following conditions have been identified that may be used to mitigate the adverse environmental impacts of the proposal:

Approximately 2,900 sf of the type-F stream buffer will be mitigated with native trees and shrubs. Species include Douglas fir, Bigleaf Maple, Snowberry, and Oceanspray that will be planted along the northern portion of the stream that is on the property to offset the impacts from the permanent driveway. The mitigation will help to bring back necessary functions of a portion of the buffer that was cleared prior to 1985 which has been maintained as a mowed field.
