## II. CODE

### **Island County Food Code 08355 Conditions of retention–Permits not transferable (FDA Food Code 8-304.20).**

A permit may not be transferred from one person to another person, from one food establishment to another, or from one type of operation to another if the food operation changes from the type of operation specified in the application as specified under 08325(3) and the change in operation is not approved.

### **Island County Food Code 08310 Application procedure–Submission thirty calendar days before proposed opening (FDA Food Code 8-302.11).**

An applicant shall submit an application for a permit at least thirty calendar days before the date planned for opening a food establishment or the expiration of the current permit for an existing facility.

## III. DEFINITION

**Change in Permit Holder:** A change in the entity that is legally responsible for the operation of an existing food establishment such as the owner, owner's agent, or other person.

**Change in Permit Holder Application:** An abbreviated plan review and licensing application consisting of:

- a. An application
- b. A copy of existing menu
- c. A floor plan drawn to scale
- d. Certified Food Protection Manager Certificate
- e. Commissary / Servicing Agreement Form (if applicable).

**Interim Permit:** A permit that is issued to a Permit Holder not to exceed sixty days to allow permit holder to submit required documentation to Health Department for issuance of new permit. Upon expiration of Interim Permit, establishment must close to the public until required documentation to Health Department for issuance of new permit is received, processed, and approved.

**No Change in Approved Plan:** No change in existing establishment's approved menu, floor plans, equipment, and/or processes.

**Permit Holder:** means the entity that:

- a. Is legally responsible for the operation of the Food Establishment such as the owner, the owner's agent, or other person; and
- b. When required, possesses a valid permit to operate a Food Establishment.

**Permit:** means the document issued by the regulatory authority that authorizes a person to operate a food establishment.
