PROJECT DESCRIPTION

The funds will pay for the maintenance and operations of all the Island County Parks properties (as described above) purchased with Conservation Futures Funds (CFF). The goal being to maintain and operate the CFF parks while enhancing the public's access and experience through projects addressing:

1. Hardscapes – bathrooms, portable toilets, parking lots, water and power systems, fencing signage, kiosks, picnic shelters and playgrounds.
2. Softscapes – lawns, trees, scrubs, mowing, trimming, pruning, pest control, fertilization and horticulture.
3. Equipment maintenance including consumables such as gas and oil.
4. Parks projects – renovations and upgrades of both hard and softscapes.

MAINTENANCE AND OPERATIONS PROJECT EVALUATION CRITERIA

A. ECOLOGICAL INTEGRITY

Regular maintenance of the Parks includes reduction or elimination of invasive species and removal of potential hazardous material out of the Parks. By removing these items it helps to preserve existing flora and grasses.

B. HAZARD OR LIABILITY

Safety is top priority for Island County Parks for its employees and park visitors. The more visits from Parks staff to these properties the better the opportunity to observe and identify hazards and address them. With these funds, Parks can maintain its CFF properties at a higher standard with more frequent visits that help to mitigate risk to Island County.

C. SPECIAL STATUS

Some of the CFF parks properties have important habitat such as riparian forest and tidelands. More frequent visits by Parks staff helps to ensure these areas are protected.

D. HABITAT VALUES NOT PREVIOUSLY COVERED

Providing public access to these properties invites new users to the sites and helps to foster an interested community group to help with stewardship of the properties. Friends of Camano Island Parks (FOCIP) are a prime example of a group that supports and participates in the conservation of these CFF properties.

E. PUBLIC ACCESS

As the park system grows and visitor trips increase, the need for more Parks staff time at these properties is important to maintain and improve safe public access.

F. MANAGEMENT PLAN

Some of the properties have existing management plans.

G. SUPPORTED BY COMMUNITY PLANS

These projects are supported by the Island County Parks and Recreation Element of the Comprehensive Plan.

H. EXISTING INFRASTRUCTURE

The opportunity to fund Parks staff time for maintenance and operations projects for these properties means that deferred projects can be continued and existing infrastructure can be better preserved.

I. DEVELOPS INFRASTRUCTURE

Island County Parks is always seeking to develop, improve and upgrade its infrastructure. These funds will allow Parks to address the need to make these infrastructure improvements.

J. LONG TERM VIABILITY

The projects that are performed in the CFF Parks improve and enhance the properties thus enabling their viability.

K. OTHER RESOURCES

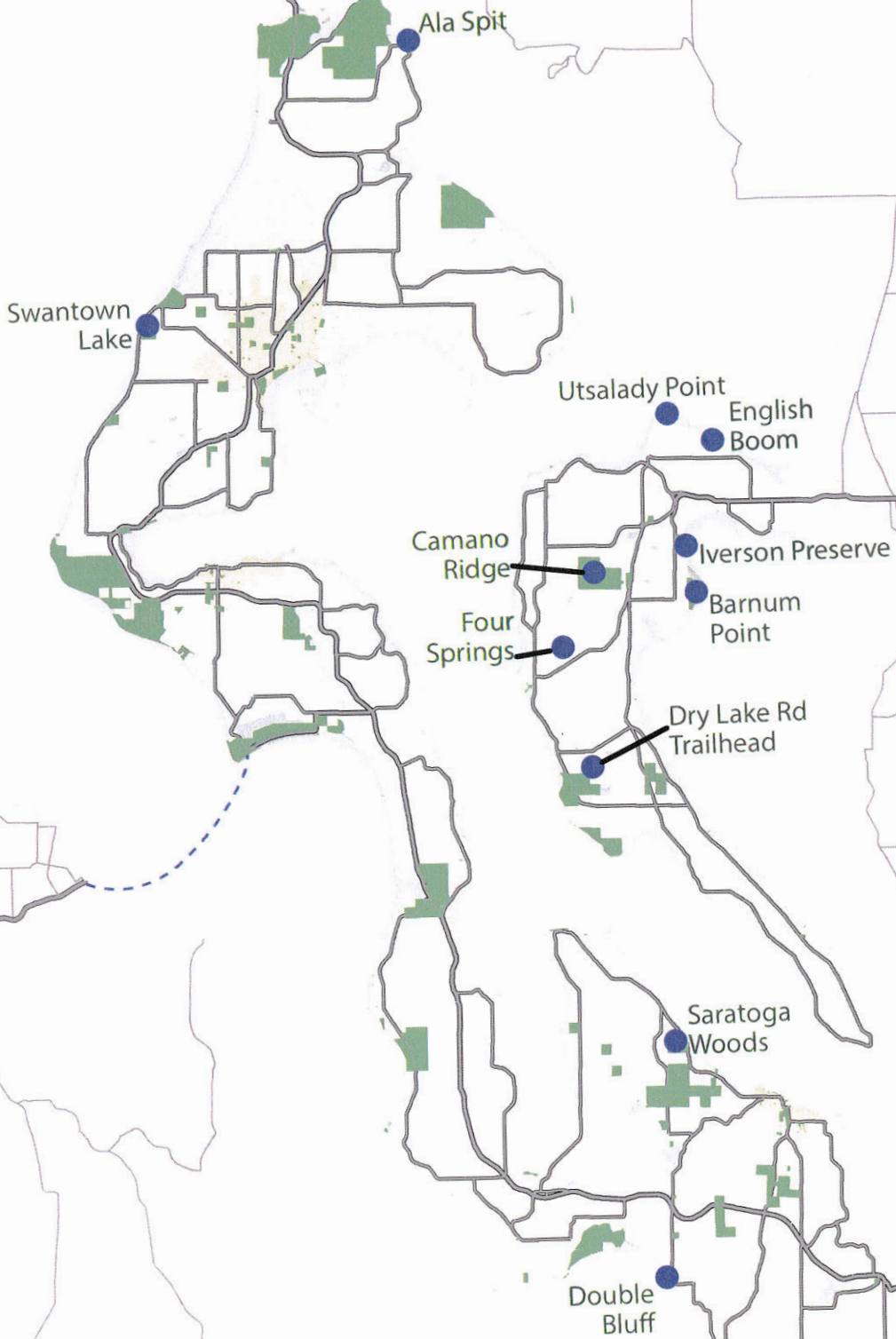
Island County Parks routinely works with volunteer labor to do trail maintenance and construction, debris clean-up, sign installation and other capital projects. Volunteers are managed through the Parks Adopt-A-Park Program and come from groups such as FOCIP and FETCH.
