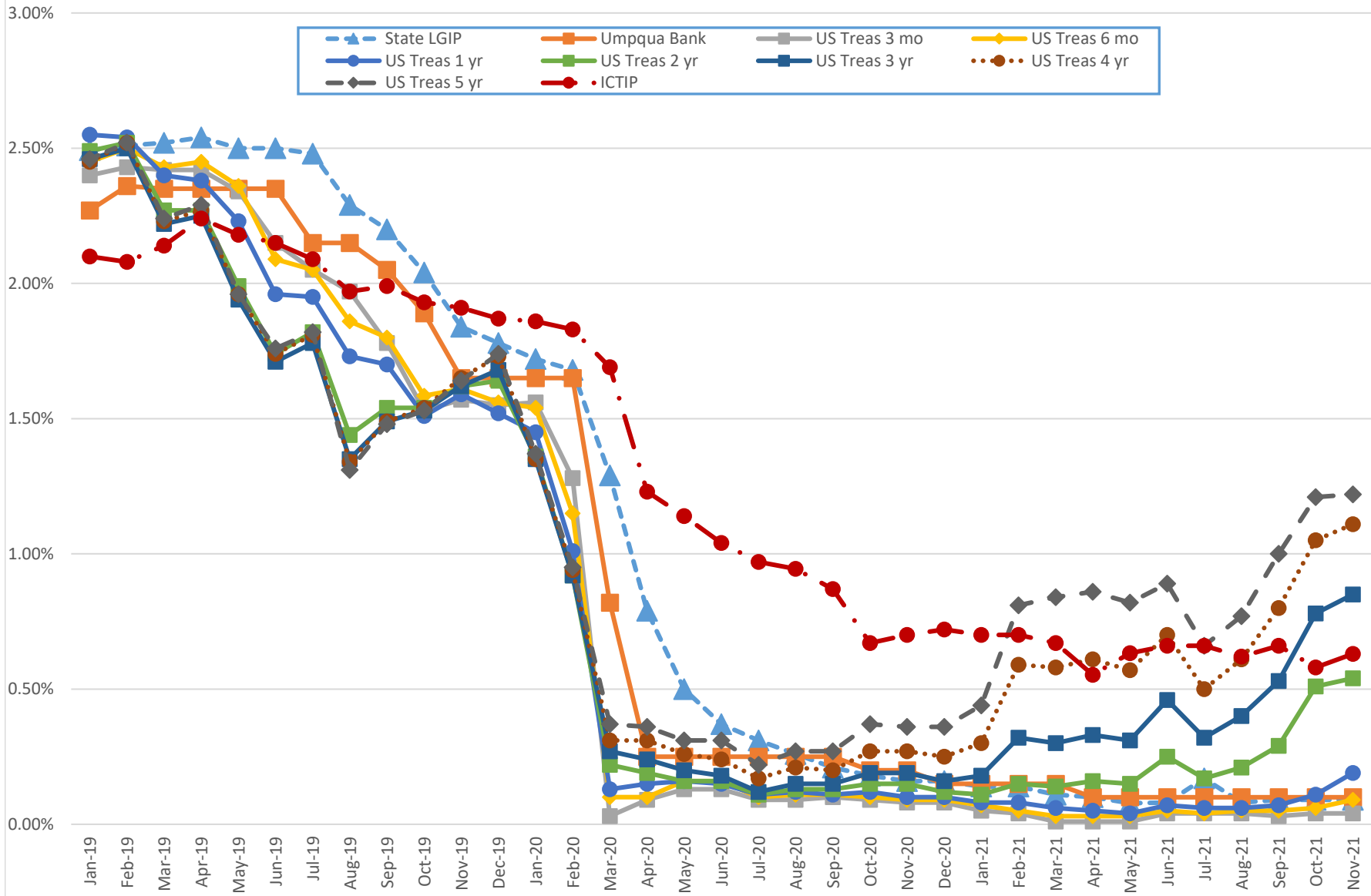

- 24% of our investment pool is currently liquid and 27% is < 1-year maturity (assuming no calls).
- As of November 30, the 2021 property tax levies for Current Expense, Roads, and Conservation Futures were 98% collected. The comparable YTD collection for November 2020 was 97%.
- Comp tax of \$1300 was collected in November; Island County's portion is approximately \$200.
- Foreclosure Update – 2021 started with 58 properties in foreclosure; currently the count is 10. The online auction begins December 7.
- Supplement Update – 276 were processed in November, with a backlog of 41.
- The number of REET affidavits processed in November was 435 compared to 416 in October and 432 in November 2020. The County's portion of excise revenue was \$533,873 in November, on sales of \$124 MM. This REET activity resulted in Island County YTD excise revenue of \$1.6 MM more than for the same period in 2020, and \$2.3 MM more than in 2019.

Investment Earnings Rate Comparison, January 2019 - December 2021



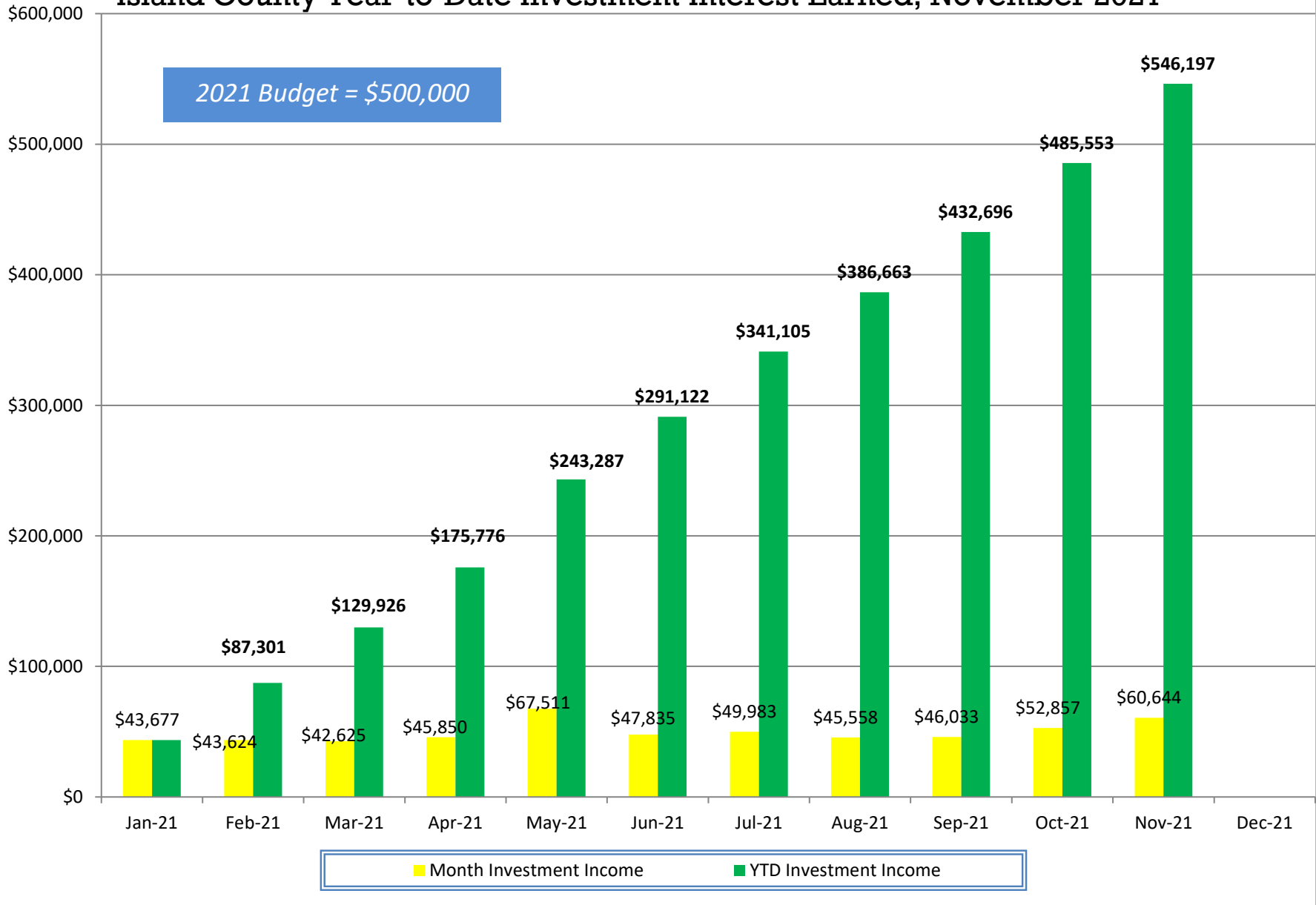

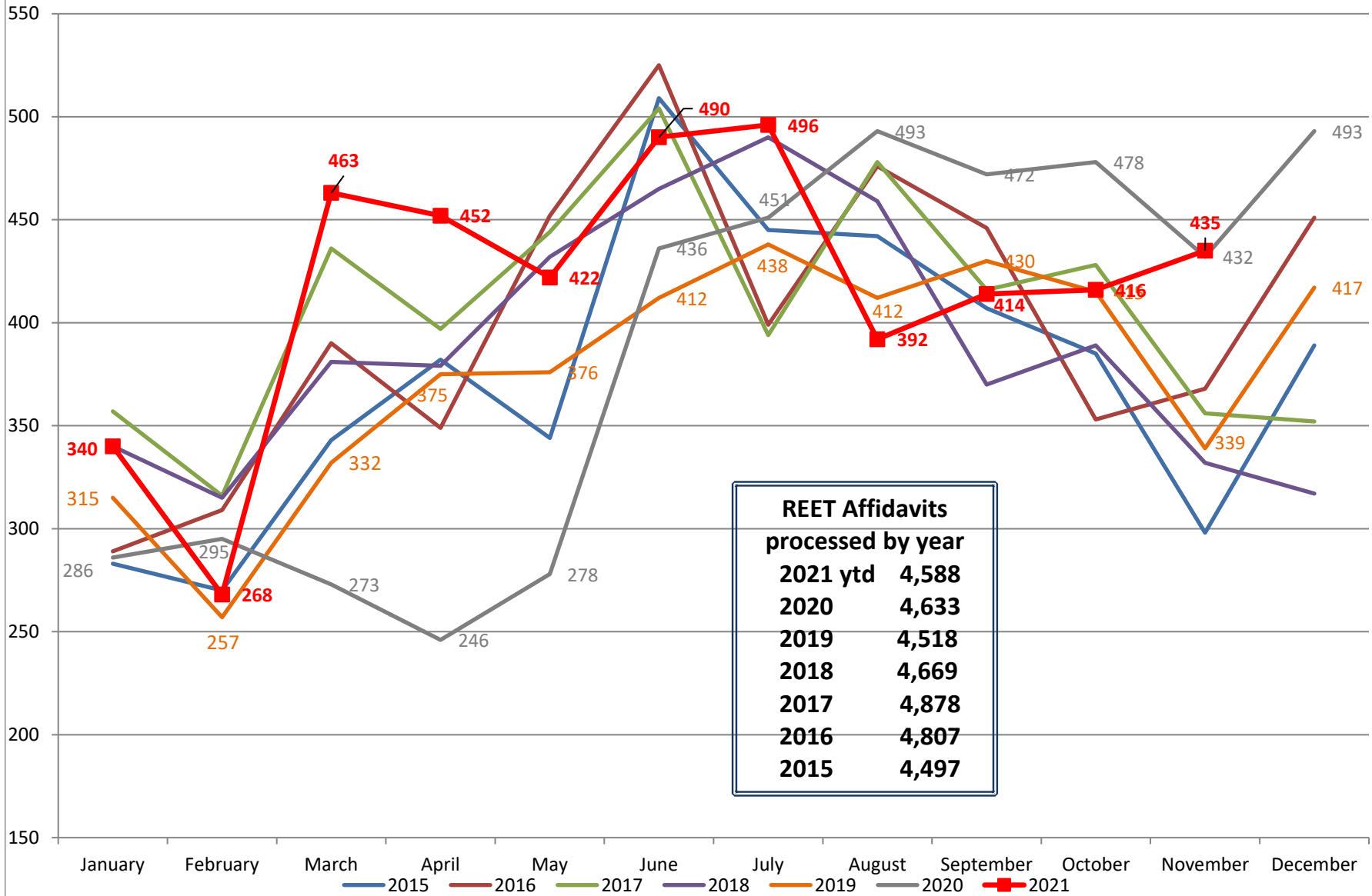

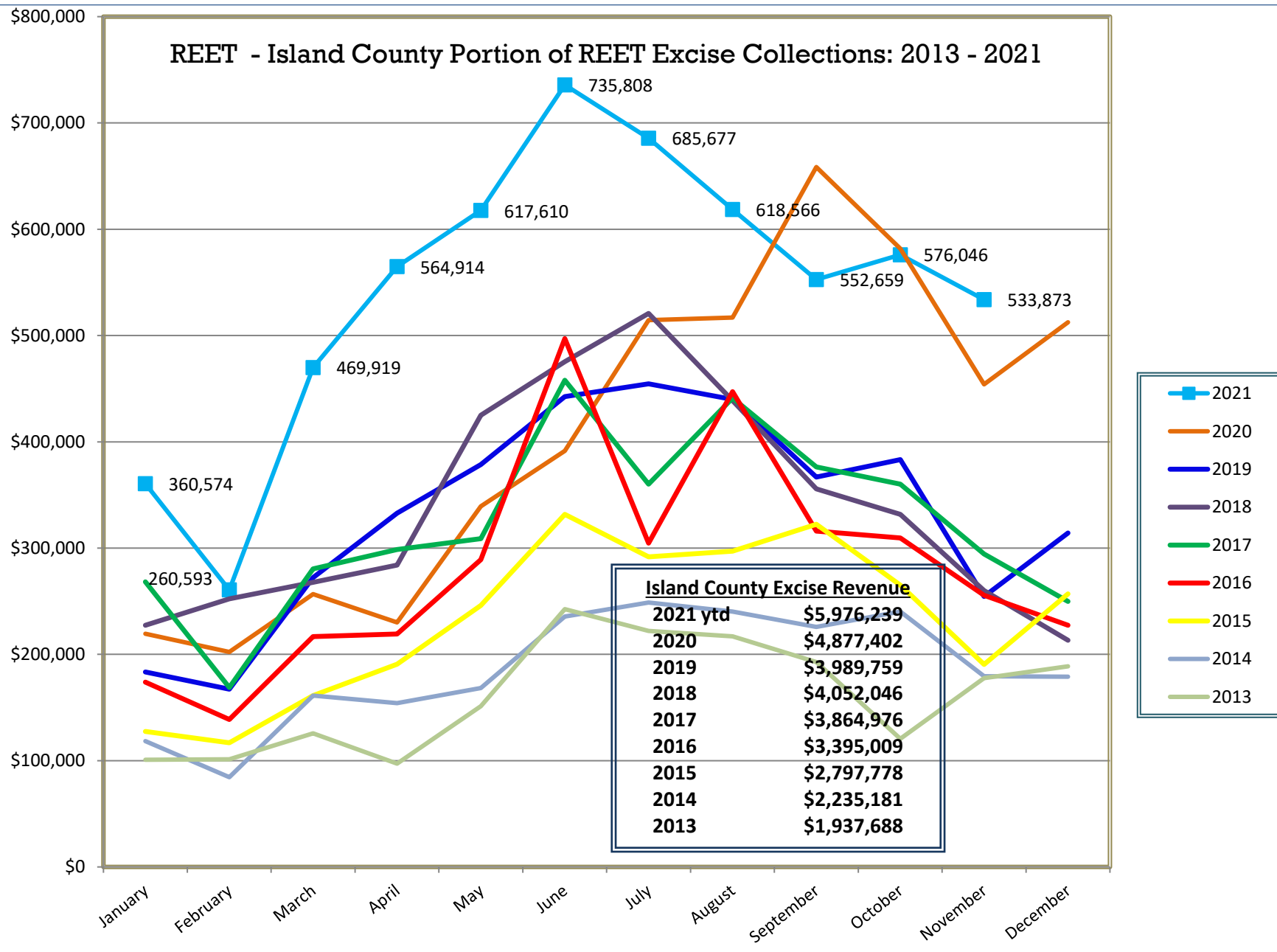


Island County 2015-21 REET - Number of Affidavits Processed by Month



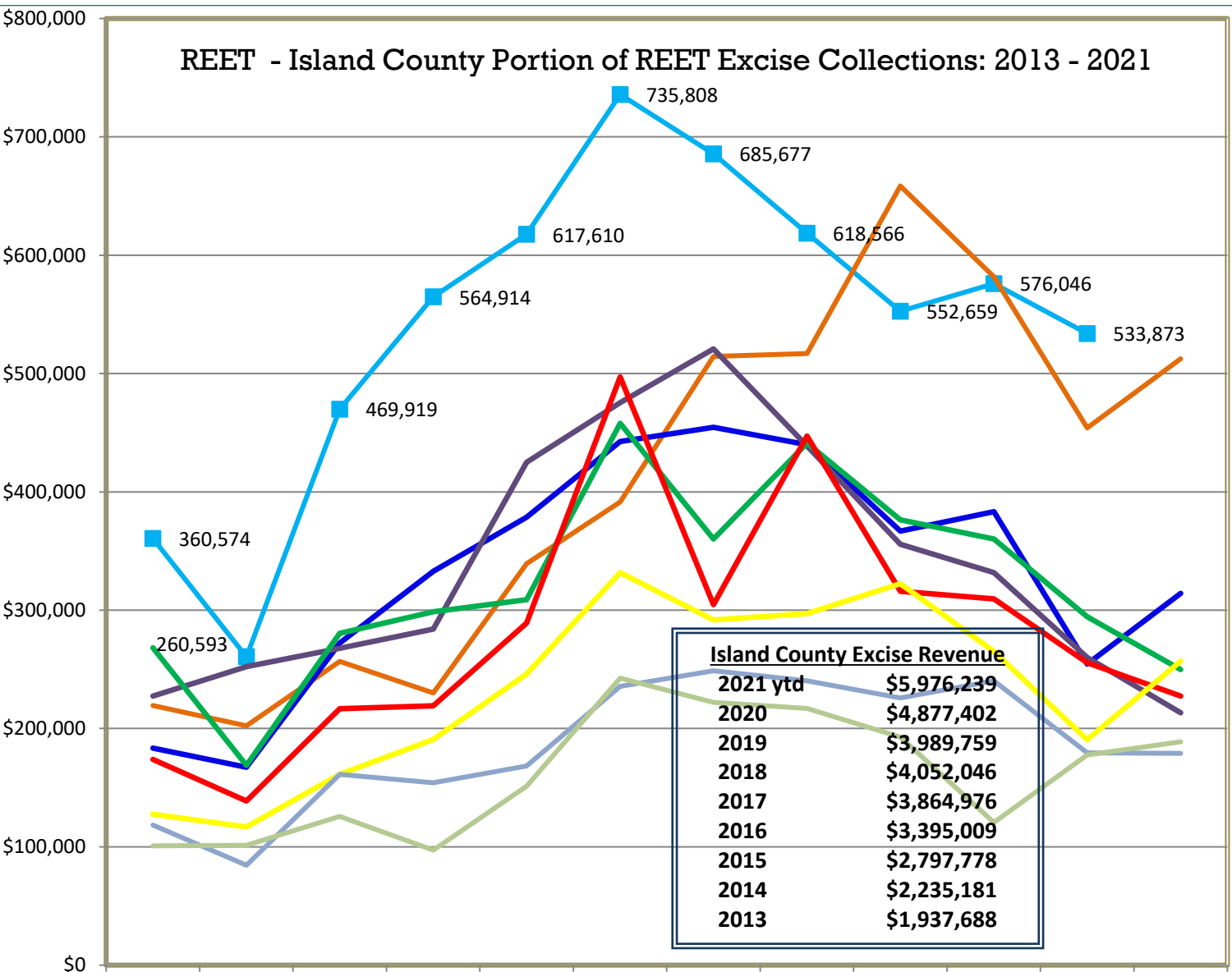
