Sign Details and Costs

Signs purchased through Island County Public Works will be made of high retro-reflectivity material rated to have a ten (10) year life span. Signs are not required to be purchased through Island County but **must** follow the Island County guidelines. Signpost(s) shall be 4"x4" and may be purchased at local retail stores.

Private Street Name Sign Cost:

Private street names may be up to sixteen (16) letters, including spaces. The extension of Ln, Rd, Dr, etc., is not included in the letter count. Prices listed for private street names include a set of two (2) single-sided signs.

Note: if requesting directional arrows to be included with the street name sign(s), the arrow shall be counted as an additional letter. The purchaser must ensure arrows are pointing in appropriate direction. Re-orders will be at the expense of the purchaser.

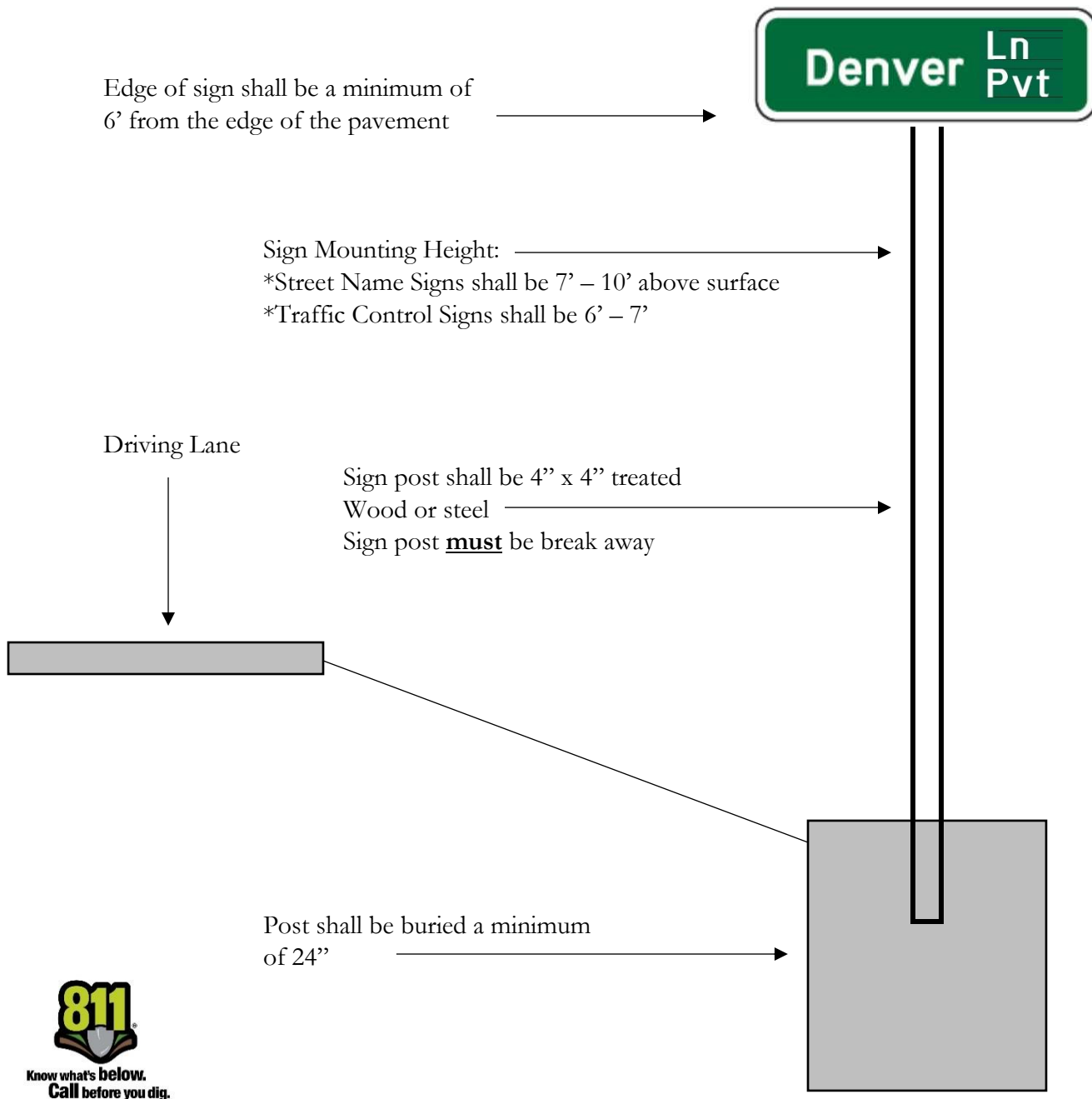

Private Road Name Sign Installation Guidelines



Anyone planning to dig should notify utilities of your intent to dig by calling 811 or making an online request a few days before you plan to break ground. Your state 811 center will inform utility operators in your area that they need to mark any buried utility lines on your property with paint or flags. They can be reached at:
