**Machine Recount of Legislative District #10, Position 1**  
**General Election – November 8, 2022**  
**Report to the Canvassing Board at Certification of Recount Results**

1. Per authorization of the Canvassing Board, on Monday, December 12, 2022 at 9:00 a.m., staff began the machine recount process. The total number of ballots undervoted in the Legislative District race were verified against the list of undervotes tabulated by the Hart Intercivic Verity system during the General Election.
2. All 674 undervoted ballots cast in the general election were accounted for and verified in the machine recount.
3. The machine recount of the race was completed and the results verified by precinct.
4. All ballots were processed according to statute by Auditor staff.
5. Differences in the votes tabulated during the recount from the tabulation in the original election results were:
  - a. Ballots where the voter did not fill in the box as stated on the ballot instructions, but used a mark in the box that was not able to be read by the scanner (light ink and small marks). The five ballots in question were attributed to the correct candidate.



