Primary Election – August 6, 2019
Report to the Canvassing Board at Certification

1. The equipment used to tabulate the ballots consists of HART Verity software and Canon Scanners. This system is certified for use in Washington State by the Secretary of State. The programming for this election was done by the Elections Division. A logic and accuracy test was performed.
2. All ballots were stored and locked in a secure area, both prior to the election and afterward.
3. All absentee ballots were processed according to statute. Experienced staff verified all signatures.
4. All ballots believed eligible for counting have been counted: 16 ballots.
5. No system problems were encountered.
6. Results were reviewed for anomalies.
7. No ballots were brought to the attention of the canvassing board for issues, as no ballots with signature or postmark issues were received.
8. Ballot count reconciliations were performed to insure that all ballots received have been accounted for.

Scatchet Head Sewer District
Initial Commissioner Terms

RCW 57.12.030, RCW 29A.60.221

The election for the three initial commissioners of the Scatchet Head Sewer District, having been on the same ballot as the question of district formation, have each received the same number of votes. A hand count of the ballots confirmed the vote count.

The vote count for each commissioner determines the initial term of office. Staggering of terms of office being required by statute, the person receiving the greatest number of votes shall be elected to a six year term, the next greatest number of votes shall be elected to a four year term and the third commissioner is elected to a two year term.

As a result of the three-way tie, per general election laws, a lot draw was conducted to determine the length of the term of office for each of the three commissioners.

The results of the lot draw are as follows:


Commissioner, Position 1	Michael Freal	<u>4</u> Years
Commissioner, Position 2	Donald Arthur Bowman	<u>2</u> Years
Commissioner, Position 3	Jerome Wager	<u>6</u> Years


