- Island Local Integrating Organization (ILIO)
 - Jenn has resigned from the DNR Manager/ILIO Coordinator position and her last day was October 26th. The position has been posted for the second time as the first round of interviews did not work out. Clea held a meeting on January 10th where there was a presentation on the Livingston Restoration project with question and answer time with the Land Trust and ESA Daniel Elefant. Ryan Elting gave a review and update of the steps in this process for completing steps for acquisition. Barbara shared information on current flooding and questions on value of property changes with current with future flooding. Tom V and Fred had similar questions.

Todd shared history and explained support for this priority area. Eric asked question about video and discussion of how many times this proposal update has been presented. Previously presented at SRTCC, at State Please join the Habitat Strategic Initiative for a series of webinars highlighting the results of two projects funded through our grant program that advance our Floodplains and Estuaries Implementation Strategy. NTA 2018-0603 Local Coordination to Advance PSNERP-identified Projects: Livingston Bay Restoration Feasibility Study

SRTCC presented one letter of support related to change in asks to add the Tulalip Tribe as a co-sponsor to the Livingston Bay Protection and Restoration grant 20-1461. The project is to acquire properties along Livingston Bay and develop a preliminary design to restore them. The Whidbey Camano Land Trust and partners will develop a preliminary design to restore 317 acres of critical

salmon and wildlife habitat in Livingston Bay on Camano Island and seize upon current acquisition opportunities if restoration is deemed feasible. The Land Trust will investigate the feasibility of restoring former tidal estuary and wetland habitat that is currently managed as diked farmland, and protect those lands and adjacent nearshore habitat to benefit coho, chum, pink, and Endangered Species Act-listed Puget Sound Chinook salmon and Puget Sound steelhead. The 317 acres targeted for restoration planning includes over three quarters of a mile of Livingston Bay shoreline and 25 acres of tidelands directly adjacent to over 7,500 acres of protected habitat within Port Susan Bay and the Stillaguamish River Delta. <https://wdfw.wa.gov/sites/default/files/publications/02139/wdfw02139.pdf>

- Mathew Lander asked questions about the tribes taking responsibility for land owners part in the diking district. Todd gave information and said that he could ask others to present from Tulalip and do Q and A. Mathew asked about the changes to the stream. PW has to provide fish passage under the road. WASDOT did not call it a fish stream in a phone conversation.
- Todd spoke on big projects and how they take time to complete. Tom spoke and verified this project would be beneficial to wild chinook. Todd spoke on the highest priority sites for Island County and one of the largest restoration projects.
- Barbara and Todd to work on letter and review with Ryan and RCO on what needs to be on the letter. Clea asked if we do need to go through a ranking process and Todd said we could review how to rank a project. In the end it was proposed to send out a draft letter for all to review. Mathew Lander mentioned that last year we supported a project like this that was less of a priority. Eric, Lee, James, and Jessica supportive of reviewing draft letter. Todd will verify with Kay on what exact words are needed for the letter. (letter reviewed and sent)
- Island County Marine Resources Committee (MRC)
 - Kelly Z. and Jessica C gave us an updated on Hoypus
 - **Hoypus Point Armor Removal Effectiveness Monitoring – Est. \$4,500 – Blue Coast Engineering/NWSF**
Northwest Straits Foundation would will apply for effectiveness monitoring for the Hoypus Point Armor removal project. Deliverables will include a series of beach profiles and beach photograph locations that would ideally be reoccupied 2 per year (May and October) to document change at the site over time and see how the site performed in terms of grain size distribution, beach slope, presence and density of large wood, vegetation which are analogs for habitat. Jessica
 - Kelly gave update on vessel removal.

1. Letters of Intent – We have 5
- **Review letters of intent submitted –**
Started with quick sharing of proposals
 1. Middle Crescent creek restoration design level by Eric M and some comments from Land Trust Kirk regarding conservation easements for farming. Review of previous restoration on the Navy base. James (WICD) project for mapping fish bearing streams.
 2. Mathew L review of proposal at Scenic Heights design level and differences from last year. Was a concern last year because of barrier upstream. Discussion of the wastewater treatment plant, maybe relocation of effluent line. Questions on wood in lagoon and channel last year.
 3. Mouth of Deer Creek/Orr Creek, and
 4. upstream culverts #271
 5. (5) Anderson and #281 (4)Humphrey Rd. Humphrey is a deep culvert. All are design only.
Mouth is at concept level to remove a fish passage barrier without moving homes. Barrier is located at the bulkhead. Concerns over flood risk. Jessica and Barbara have concerns. Todd asked questions about regulating Deer lake.
- Decide on invitations for full proposal – Todd requested to send summary out to everyone and request feedback. Request back for comments quickly as the applications due the 13th of February. Request for 1 week turnaround. Mathew requested feedback as soon as possible.
