

- 15% of our investment pool is currently liquid and 18% is < 1-year maturity (assuming no calls). Including our bank balances, liquidity of total balances is 22%, which satisfies our Investment Policy criteria.
- Property tax statements were mailed February 22. As of February 28, the 2022 property tax levies for Current Expense, Roads, and Conservation Futures were 1% collected. The comparable 2021 YTD collections in February 2021 were 3%.
- Foreclosure Update – 2022 started with 58 properties subject to foreclosure, and 22 mobile homes subject to distraint. As of February 28, the count is down to 44. Collection procedures are ongoing to avoid auction of these properties.
- The number of REET affidavits processed in February was 284 compared to 300 in January and 268 in February 2021. The County's portion of excise revenue was \$285,310 in February, on sales of \$79 MM. This REET activity resulted in Island County YTD excise revenue of \$4,144 more than for the same period in 2021, and \$203,562 more than in 2020.

## Investment Earnings Rate Comparison, January 2019 - February 2022






