

- 18% of our investment pool is currently liquid and 25% is < 1-year maturity (assuming no calls). Liquidity of total funds including bank balances is 21%, which satisfies our Investment Policy requirement of 20% minimum liquidity. We have 100% participation in our Investment Pool by Island County junior districts.
- Property tax statements were mailed February 22. As of November 30, the 2022 property tax levies for Current Expense, Roads, and Conservation Futures were 98% collected. 2021 YTD collections for November were also 98%.
- Foreclosure Update – 2022 started with 58 properties subject to foreclosure and 22 mobile homes subject to distraint. The 2022 Certificate of Delinquency was filed August 8. As of November 30, the count is down to 4 and 0, respectively. The tax foreclosure auction is scheduled for December 7-8, 2022.
- The number of REET affidavits processed in November was 227 compared to 304 in October and 435 in November 2021. The County's portion of excise revenue was \$291,285 in November, on sales of \$67 MM. This REET activity resulted in Island County YTD excise revenue of \$961,535 less than for the same period in 2021, and \$649,646 more than in 2020.

## Investment Earnings Rate Comparison, January 2019 - November 2022






