One mini-grant will not be completed with permitting complications related to permitting of boat rail removal. Mathew reminded us that a lesson learned would be to note that the applicant was looking to install a new boat ramp and we would have ranked differently if we knew that the home owner would want to install something new to replace what was looking to be removed. More background information in the future should be gathered for mini grants. WDFW noted that the HPA permit complication was related to owners not wanting to do the extra work to have forage fish study. Barbara reminded us that we should look at cost of forage fish surveys for future projects. Race mini grant moving forward. Mini grant for video at Hoypus being updated. Planting for Hoypus and Cornet mini grant almost complete. Thanks to Kelly Z for riparian care for success of projects and watering work.

New- Riparian guidance for funding Riparian Funding- This program has been funded in part or wholly by Climate Commitment Act associated funding. The Climate Commitment Act (RCW 70A.65) created a market-based program to help reduce greenhouse gas emissions in the next few decades. A portion of the revenues are directed into the Natural Climate Solutions Account and were distributed into several standing grant programs, including this riparian specific program. Funding comes with additional reporting, assessment, and tribal consultation requirements. Core Funding Objective- Enhance salmon recovery through the protection and restoration of fully functioning riparian ecosystems. Riparian projects include freshwater, marine near-shore, and estuarine activities that will improve or protect the riparian habitat outside of the ordinary high-water mark or in wetlands. In the past we have been able to recommend projects seeking this funding when projects do not have enough salmon benefit potential for success in SRFB review.

SRFB 2024 grant round: SRFB regular ~\$290K • This total is likely to increase based on the final approved budget. Funding will be available in Fall 2024. This is only for this year.

SRFB New Riparian: ~\$445K • Funding will be available in Fall 2024 Manual 18 will contain the updated appendices containing this new policy in early 2024. Money may not carry to the next year PSAR: ~809K
• Used to fund restoration and acquisition through the Lead Entity SRFB process. Funding will be available in Fall 2025.

• January 16th: Letters of Intent were due to LEC [Here](#). Grant round is open in PRISM. Projects can be entered into the Salmon Recovery Portal (SRP) before this date but cannot be sent from SRP to PRISM until January 16th. We reviewed 5 projects and 4 of which are ready to move to PRISM. Projects will be going through changes and we will have more details in the future. For details review snapshots. The 5th project is a private fish passage design and more information will be shared if project moves forward to PRISM. Projects are in Preapplication status and use discretion in discussing details until full application status. All projects look to meet the basic requirements needed to push to PRISM.

• February 14th: All draft SRFB /Riparian/PSAR applications due in PRISM. February 21st, we meet to review how we evaluate projects. February 28th: Presentations and Site Tours all SRTCC to attend and sponsors. March 20th sponsor to present projects virtually. March 28th Applicants receive their first comment from the SRFB review panel which will identify their projects as Clear, Conditioned, Needs more information, or POC. We had 5 projects last year and only 2 made it to final ranking. We had one project come back to us from a previous year, as a cost overrun. February 28th we will have a representative from PSP on the site visit as well as the 2 RCO/SRFB review team with Bridget the grant manager. A van has been reserved, look for a poll and request for RSVP. We will review how to look at projects.
